- 2. Annual Income of the student's Parents/Guardians from all sources should not exceed Rs. 2 lakh.
- 3. The Students who have been sanctioned Post-Matric Scholarship FRESH / Renewal in 2012-13 are eligible for Renewal in 2013-14 if they have scored above 50% in previous semester / year final examination and studying in the same course.

IMPORTANT POINTS FOR STUDENTS BEFORE FILLING THE ONLINE APPLICATION

- 1. **ENTER CORRECT DETAILS:** Kindly don't hurry while filling the ONLINE APPLICATION. Enter all details correctly.
- 2. QUALIFYING EXAM Marks :

(a). If you are studying in 1st Semester of a Course, then the previous course final sem/year marks must be indicated & Photocopy of the Marks Card / ONLINE Result must be attached.

(b). If you are studying in 2nd or 3rd or 4th or 5th or 6th Semester, you have to enter the marks secured in 1st or 2nd or 3rd or 4th or 5th Semester & photocopy of the Marks Card/ONLINE result must be attached.

If the Previous Final Sem/Year Marks Card Photocopy or ONLINE Result Copy is not attached and if any discrepancy is found in the Previous sem/year Marks filled ONLINE & the Photocopy of the Previous sem/year Marks Card attached, such applications will be REJECTED.

- 2. The Qualifying Exam (QE) %: For UG Students Overall Percentage in 2nd PUC / 12th. For PG Students – Aggregate % of all Semesters / Years of UG Course Studied.
- 3. Annual Income of the student's Parents/Guardians from all sources should not exceed Rs. 2.5 lakh.

- 4. The Students who have been sanctioned Merit-cum-Means Scholarship FRESH / Renewal in 2012-13 are eligible for Renewal in 2013-14 if they have scored above 50% in previous semester / year final examination and studying in the same course.
- 5. Students doing their Final year Internship cannot apply.

(a). If you are studying in 1st or 2nd or 3rd or 4thyear of Graduation, the Qualifying Exam (QE) is 12th STD / 2nd PUC. Hence all UG students must enter their overall 12th / 2nd PUC Marks as Qualifying Examination Marks.

(b). If you are studying 1st or 2nd or 3rd year of Post Graduation, the Qualifying Exam (QE) is the Degree Course. Hence all PG students must enter their Aggregate Marks of all Semesters/Years as Qualifying Examination Marks (Degree course).

The Qualifying Exam Marks once entered cannot be changed. If any discrepancy is found in the QE Marks filled ONLINE & the Photocopy of the QE Marks Card attached, such applications will be REJECTED.

- Family income of the student from all sources should be less than Rs. 1,00,000/-(Rupees one lakh only) in the preceding financial year: In case of salaried class...more
- Should have Confirmed admission in class-XI...more
- The University/College/ Institute offer ing admission should be recognized by the Government at the Central or State level or any other competent authority.
- It is one time scholarship, and no claim as permanent beneficiary will be entertained. Student once selected for scholarship can not avail the same again.
- A student getting a scholarship from any other source would not be eligible for this Scholarship.
